Highlights: On the occasion of the **China Arbitration Week 2024** a “**SPANISH ARBITRATION DAY in BEIJING NINETH EDITION: NEW DEVELOPMENTS IN INTERNATIONAL ARBITRATION, II**”, organized by Mr. J. Félix de Luis and Club Español e Iberoamericano del Arbitraje (CEIA) and Peking University Law School, supported by China International and Economic Arbitration Commission(CIETAC), will take place **in person**, in Beijing, CHINA, on 25 September.

The event will be held offline on **THE NEW DEVELOPMENTS IN INTERNATIONAL ARBITRATION**, analyzing the new circumstances in connection with International Arbitration from the perspective of Spain and Latin America in light of the “*Report of the Commission to promote Spain as a Seat for International Arbitration*”.



The Seminar will give a glance from different perspectives of Spain and Latin America and the role that the Spanish arbitration community can play in international arbitration.

Spain is viewed by foreign companies, mostly European and increasingly also Asian companies, as a springboard for doing business in Latin America, and vice versa, for Latin American companies to get into European markets, and recently also into Africa, through Spain.

In short, Spain can play a triangle role in the field of international arbitration between Latin American and European countries, on the one hand, and between Latin America and Asia, on the other. For everything related to Latin America, Spain is a dispute resolution centre of the very first order. Spain could be a "natural forum" for international arbitration for those parts of the world.

Participants will learn about the latest development regarding international arbitration in Spain and Latin America and the Asia-Pacific.
